### **Unfinished Business**

  any decision. Nicole will call to be put on the agenda.

- Cedar Lake Ordinance limiting the number of slips and piers. Talked about who is responsible for enforcing this ordinance.
- Land Use Committee has shut down because we didn't seem to be making progress.
