We now accept credit/debit card or E-check payments via the Polk County website at www.polkcountywi.gov
 E-check fee is \$1.50. Credit/Debit card fees are 2.99% with a minimum fee of \$2.95. (This is equivalent to \$30.00
 per \$1,000 being paid) We still have our drop box located by the front door if you prefer that method.

If you need your tax payment receipted in December 2025, I will need the payment to be onsite no later than
 12/31/2025; otherwise, the payment will be receipted as a 2026 payment. Accepting postmarked envelopes is only
 used to determine interest and penalty, not when the payment was received.
